In 2012, the Sustainable Apparel Coalition (SAC) launched the HIGG Index Facilities Environmental Module, a self-assessment standard for the apparel and footwear industry, to assess environmental sustainability throughout the supply chain. The standard was co-authored by numerous brands, the United States Environmental Protection Agency, and nonprofit entities

Utilizing the Higg Index, a brand or retailer can generate a complete overview of the sustainability performance of their organization, supply chain partners and products. The information garnered from the verifications can then be used to create action plans for continual improvement.



The Higg Index Facility Environmental Module covers the following 7 key areas:

- Environmental Management System (EMS)
- Energy Use and Greenhouse Gas (GHG) Emissions
- Water Use
- Wastewater Effluent
- Air Emissions
- Waste Management
- Chemical Management
