The need for sustainable fashion

At the 2019 Textile Exchange Sustainability conference, more than 36 major brands pledged to achieve sustainable cotton by 2025. This pledge shows that there is a demand for more sustainable fashion and that companies are willing to help drive these practices across the sector.

Why Textile Exchange certification?

Textile Exchange identifies and shares best practices regarding farming, materials, processing, traceability, and product end-of-life in order to reduce the textile industry's impact on the world's water, soil and air, and the human population. They influence the textile industry across the supply chain through their partnerships and collaborations, building knowledge and capacity to inform and educate. Their goals include:



- Embed sustainability into evolving business and supply chain strategies
- Make it easier for companies to adapt to changing opportunities and requirements in textile sustainability
- Ensure that actions taken toward sustainability result in real and meaningful change

Textile Exchange developed several important industry standards, including:

- Content Claim Standard (CCS) sets the requirements for certifying the chain of custody of third parties. CCS supports all Textile Exchange standards and ensures chain of custody integrity from raw material to finished product.
- Global Recycled Standard (GRS)
 establishes requirements for third-party
 certification of recycled content, chain
 of custody, social and environmental
 management, and restrictions on the
 use of chemicals. The goal of GRS is to
 increase the use of recycled materials in
 products and reduce/eliminate damage
 caused by their production.
- Recycled Claim Standard (RCS) sets the requirements for third-party certification of recycled content and chain of custody. The goal of RCS is to increase the use of recycled materials.
- Organic Content Standard (OCS) is

an international, voluntary standard that sets requirements for third-party certification of certified organic input and chain of custody. The goal of the OCS is to increase organic agriculture production.
